Prior to your move out
submit notice to vacate at least 20 days prior to your move out date. Turn this into the Acacia Court office.
contact any additional services such as Comcast or Qwest to
cancel your services submit a forwarding address to the United States Postal Service either online, www.usps.com , or at the nearest Post Office (University Avenue)
schedule a move out inspection with the office if you would like to be present during the inspection. <i>Keep in mind you cannot dispute any issues if you are not present for the inspection.</i>
During your move out
clean your complete apartment Bathroom (clean toilet, bathtub, sink, cabinets, and floor) Living area (clean desk, closet, fridge and microwave, vacuum floor) clean out kitchen locker and remove all food items and appliances Failure to complete any of the above may result in cleaning charges
The last things you should do
Move out inspection if you scheduled one (apartment has to be completely empty)
Turn in your keys (your last day of occupancy will be the day you turn in all your keys. If you have lost a key please submit a note indicating which key is missing. You will be charged for missing
keys). Failure to turn in your keys by your scheduled move out date will result in additional charges.
We will turn off your electricity and Seattle City Light will forward your last bill.
